1. Purpose

This document is intended to communicate the standards and guidelines to be followed by the tenants of chemical warehouse units.

2. Scope

Applicable to all relevant chemical warehouse units.

5. General

- **5.1** The allocated warehouse space shall only be used for permitted chemical storage.
- 5.2 The unit shall not be used for direct sale or retail purpose.

6. Guideline Details

6.1 Modification and Installations

- 6.1.1 Any modifications to structural element is prohibited.
- **6.1.2** The tenant should be responsible for any damages incurred to the property and/or its users in installing / modifying any component of the unit.



- **6.1.3** No signs, directories, posters, advertisements or notices shall be painted or affixed on or to any of the windows or doors, or in corridors or other parts of the building, and in any case shall be first approved in drawing by HDC in its discretion.
- 6.1.4 Tenant shall not make any changes or alterations to any portion of the Warehouse Unit without HDCs' prior written approval, which may be given on such conditions as HDC may elect. All such work shall be done by HDC or by contractors and/or workmen approved by HDC, working under HDC's supervision.

6.2 <u>Warehouse Cleaning and Safety</u>

- **6.2.1** The tenant must comply the Hazardous Chemical Regulation 2019/R-1057 from Ministry of Defence.
- **6.2.2** All waste produced should be removed in accordance with the relevant authorities' regulations.
- **6.2.3** Each Tenant shall cooperate with cleaning Staffs in keeping leased premises and common area neat and clean.
- **6.2.4** No machinery of any kind shall be operated on leased premises or any area of the building without the prior written consent of HDC.

6.3 <u>Others</u>

- **6.3.1** The tenant must comply with relevant authority guidelines while operating the unit.
- **6.3.2** The tenants are not allowed to keep goods belonging to lessee in the common area or keep garbage outside the premises.
- 6.3.3 Common areas shall only be used

for the purposes for which they are designed for.

A written confirmation should be obtained from HDC if the common areas are to be used for any other purpose.

- **6.3.4** Vehicles are not to be parked in any area inside the warehouse premises except for the purpose of loading and unloading in accordance with the floor marking.
- **6.3.5** The Loading and Unloading process should be carried out in a manner such that the area is not congested.

7. Disclaimer

HDC reserves the right to evaluate and impose conditions not covered in these guidelines in response to specific design or usage depending on merits. HDC reserves the right to modify or withdraw any part of this guideline and to make such other and further changes as deemed necessary for the operation of the warehouse units and these guidelines will be binding upon each tenant.

8. Review

A review period of 1 year (Annually) or as required will be practiced during which HDC shall review the contents of the guideline for its relevance and accuracy and fitness for purpose of the assigned Warehouse units.
