



	Enquiry	Response
1.	Could you please provide us the details of all the necessary documents which are required for the submission of the bid?	All the necessary information regarding the bid submission will be available in our RFP document uploaded to HDC Corporate website and myhulhumale' properties website. For the details of the RFP, please visit our websites (https://properties.hdc.com.mv/) and (https://hdc.com.mv/).
2.	Is there a specific usage allocated to the units which were announced under this RFP?	Yes, the units should be used to operate any type of retail stores.  Please refer to RFP, Section V, Clause 1.
3.	Is the unit appropriate to operate a retail hardware shop?	Yes. Please refer to RFP Section V. Lessor's Requirements for details of restricted usages.
4.	Can any proponent submit the proposal without participating in the pre-proposal meeting?	Yes, any interested Proponents can submit the proposal.
5.	Will there be a grace period without payment of rent for working on the store outlet finishing?	Yes. Three months grace period will be given from the date of unit handover.
6.	Does selling canned foods and canned drinks also fall into F&B related category which is not allowed in the unit?	Sales of canned foods and canned drinks does not fall into F&B related category specified in the RFP. Please refer to RFP Section V. Lessor's Requirements for details of restricted usages.



7.	What is the finishing status of the outlet? (electricity wiring, sockets etc, walls painted, ceiling, flooring tiles)	The units leased under this RFP are bare shell units. Electricity provisions are provided.
8.	Is there any access to the units in addition to the main entrance? Can a side entrance be installed?	There are no side entrances to the units and installation of additional entrances will not be permitted.
9.	Can the Lessee install a toilet inside the unit? Is there any specific spot allocated to install a toilet by Lessor or can Lessee allocate a spot for toilet installation?	Toilets can be installed to the locations where sewerage lines are currently present, with HDCs approval and as per provided guidelines.
10.	Is there anyway of inspecting the area before the deadline of the submission?	HDC will not be conducting any site visits. However, the Hiya area is now open for public.

29.	Can a business operating for only 1 year, submit a proposal?	Yes.

39.	Can a single party propose the bid for more than one unit from the allocated units?	Each proponent shall submit only one proposal under this RFP. 40.	Will the agreement be renewed after the 5-year lease term? If not, will be awarded to the same proponents after the first 5 years?	Agreement will not be renewed.  As per Section VI. Term-Sheet, Clause 5.2.  After the completion of lease term, the lessee shall vacate the unit.
