1.	Is it possible to visit the allocated site before proposal submission?	A site visit will be arranged by HDC and the details of this will be announced on HDC Corporate website and MyHulhumale Properties website.
2.	Are there toilets built in the unit?	As per Section V Lessor's Requirement Clause 3 Drawings, toilets are there in the unit.
3.	What are the walls which are built?	As per Drawings pillars and walls shown in the drawing are build.
4.	Do we have to renew the agreement after 5 years?	Agreements will be signed for 5 years' term with the winning party. There is an option to renew agreement as per Section VI. Contract Terms Clause 11.
5.	Is there a basement in this area?	There are no basement area allocated with the units.
6.	Can we have the separate entrance for the clinic area?	Entrance for the units are from the building corridor and there is no separate entrance.
7.	What is the progress of the finishing work done in this unit?	Our estimated timeline to handover the units is by the end of March 2021.
8.	Will it be possible to remove a wall which is already built and make adjustments as such?	Internal Modification is allowed with prior approval from HDC in accordance with Section V. Lessor's Requirement Clause 4 Hiyaa Commercial Guideline Clause 8.1.
9.	Will the grace period increase, if HDC is unable to handover upon the agreed date?	Grace period will be 3 months from the date of unit hand over as per Section VI. Contract Terms Clause 8.
